

## INFORMATIVE

### **Informative note pursuant to article 13 of Legislative Decree no. 196, 30th June 2003 (Personal data protection code)**

Pursuant to art. 13 of the Personal data protection code adopted with Legislative Decree no. 196, 30th June 2003 (hereinafter "Code") and in relation to personal data, including sensitive data, which relates to you and which shall be the object of data handling, Azzurra Group s.r.l. società unipersonale provides you with the informative note requested by the Code in regards to handling and disclosure practices associated with the operations and services you have requested. The informative note and consent also refers to handling and disclosure practices carried out by third-party companies, the list of which is available at the Azzurra Group s.r.l. società unipersonale head office, which publish, promote or distribute Azzurra Group s.r.l. società unipersonale products and services (hereinafter "Distributors").

#### **1. Purpose of data handling**

Handling

- a) The purpose is to finalise, manage and execute contracts relative to activities for the production and commercialisation of taps and fittings, shower closures, shower boxes, shower systems and bathroom fixtures, in addition to the fulfilment of legal provisions;
- b) The purpose may also relate to providing information and commercially promoting products and services dealt with by Azzurra Group s.r.l. società unipersonale, to define its commercial profile, to send information and commercial proposals.

#### **2. Data handling method**

Handling

- a) Is carried out through operations or sets of operations: collection; registration and organisation; processing, including modifications, selection, extraction, comparison/interconnection; use, including consultation, communication; preservation; cancellation/destruction; safety/protection, including accessibility/confidentiality, integrity, protection;
- b) It is also carried out using electronic or in any case automated means;
- c) It is carried out directly by Azzurra Group s.r.l. società unipersonale and by parties belonging to the internal and external organisational structure of Azzurra Group s.r.l. società unipersonale, in the capacity of autonomous data controllers, parties responsible for and/or appointed to handling.

#### **3. Provision of data**

Without prejudice to the personal autonomy of the concerned person, the provision of personal data may be:

- a) Obligatory based on the law, regulations or European legislation (for example tax legislation);
- b) Strictly necessary to finalise new relations or manage the execution of existing relations or manage existing contracts;
- c) Optional for activities that relate to providing information and commercially promoting products to the interested party.

#### **4. Refusal to provide data**

Refusal by the interested party to provide their personal data

- a) In the cases described in point 3, lett. a) and b), involves the impossibility to finalise or execute the relative contracts;
- b) In the case described in point 3, lett. c), does not involve any consequences for existing relations or during their constitution, but may preclude the possibility to carry out activities that relate to providing information and commercially promoting products to the interested party.

#### **5. Parties to whom data may be disclosed or who may become aware in the capacity of managers or persons in charge**

- a) The personal data may be disclosed by Azzurra Group s.r.l. società unipersonale or by third parties in charge - for the purposes described in point 1, lett a), to be handled for the same purposes or to fulfil legal obligations: consultancy studies; services companies in charge of managing the data, as well as filing services companies; supervisory bodies and authorities and other databases in cases where the disclosure of data is mandatory;
- b) Moreover the personal data may be disclosed, for the purposes described in point 1, to companies belonging to the parent company (controlled companies, controlled and connected companies, even indirectly, pursuant to legal provisions in force);
- c) Certain persons in charge of handling, may access your personal data in order to fulfil the tasks for which they are responsible. Parties appointed by Azzurra Group s.r.l. società unipersonale to be responsible for handling may also become aware of your personal data when carrying out the tasks assigned to them.

#### **6. Data dissemination**

Personal data is not subject to dissemination.

#### **7. Transfer of data abroad**

Your personal data may be transferred to European Union countries and non European Union countries in respect of the provisions of art. 43 and 44 of the Code.

#### **8. Rights of the interested party**

Art. 13 of the Law grants the interested party specific rights, including the right to obtain confirmation from the data controller of the existence or otherwise of their personal data and its availability in an intelligible form; to have knowledge of the origin of the data, as well as the logic and purposes on which its handling is based; to know the identifying details of the Controller and any assigned Responsible Parties, as well as parties or categories of parties to which the data may be disclosed or which may become aware of the data in their capacity as responsible persons or persons in charge of its handling; to obtain the cancellation, transformation into an anonymous form or blockage of data handled in breach of the law, as well as request the updating, rectification or if desired, integration of data; to oppose, for legitimate reasons, the handling itself, even if it is pertinent to the scope of its collection and to oppose the handling of their own data for the purpose of sending marketing material, or for direct marketing or to carry out market surveys or send commercial communications. The rights described in art. 13 can be exercised by submitting a request to the Azzurra Group s.r.l. società unipersonale head office.

#### **9. Data Controller**

The data controller is Azzurra Group srl società unipersonale with registered offices in via Codopè, 62 - 33087 Cecchini di Pasiano (PN). The data controllers are also the single Companies used by Azzurra Group s.r.l. società unipersonale. The continuously updated list of data controllers and parties responsible for handling, appointed by Azzurra Group s.r.l. società unipersonale, is available at the company's head office.
